# Section 4. Appointment of officers of customs. -

(1) The Board may appoint such persons as it thinks fit to be officers of customs.

(2) Without prejudice to the provisions of sub-section (1), Board may authorise a Principal Chief Commissioner of Customs or Chief Commissioner of Customs or a Principal Commissioner of Customs] or a Joint or Assistant or Deputy Commissioner of Customs to appoint officers of customs below the rank of Assistant Commissioner of Customs.
