TRAINING CIRCULAR

Sub: Offline Training programme for Department of Revenue Intelligence Course to be conducted from 03rd June 2024 to 15th June 2024 at Military Intelligence Training School & Depot- reg.

A two weeks offline training programme for Department of Revenue Intelligence Course will be conducted by **Military Intelligence Training School & Depot (MINTSD), Pune** from **03rd June 2024 to 15th June 2024**

2. Eligibility:

Officers of the rank of Income Tax Officer/Superintendent to Principal Commissioner/Principal Director.

3. Course Content

Intelligence, Intelligence Tradecraft, Espionage, Cultural Intelligence, Surveillance, interrogation, Talent Spotting, etc.

4. Training Course Fee:

(i) For Officers (Pay Band 10 & above) - **Rs.27,936/-** per officer which is to be paid through a Demand Draft / Cheque.

(ii) For Officers (Pay Band 9 & Below) - **Rs.6,776/-** per officer which is to be paid through a Demand Draft / Cheque.

5. Nominations:

- a) It is requested to circulate this Training Circular among all eligible officers and nominate eligible officers for the said course. **As there are total of 20 slots, first come first served nominations are likely.**
